Dear Amy

I am writing to SRK to request an extension for I&APs to submit comments on the revised BAR. As you may know, many of the I&APs have been extremely busy with other legal and procedural processes related to the proposed River Club Development.

The revised BAR contains new information which I&APs have to be able to digest and formulate measured responses.

Most I&APs are community members with full time job and do not have the time in their working hours to spend reviewing documents, which are my count, involve 194 pages of actual report plus 47 appendices totalling over 2000 pages (not including the 11 appendices with comments from I&APs on the BAR).

Secondly, there are a lot of files that appear out of sequence, which makes it different to understand the layout of the overall report. For example, I am puzzled by HWC comments on the HIA should be sequestered in a separate appendix E1, along with water, waste, electricity and sanitation, since it surely belongs with the HIA documents.

Then, of course, it is difficult for IAPs to fathom that you have listed all documents from way back to the Draft Scoping Report, some of which have changed but some of which have not, so it makes it that much harder for the IAP.

Lastly, none of the reports actually earmark what is different from previous reports and shift that burden of discovery onto the I&AP. That is a huge amount of work.

For all these reasons, I do not believe a deadline of 30 days for comment on such a humungous set of documents is reasonable.

I am therefore writing to you to ask that the deadline for comments be extended by a further 30 days to allow I&APs a reasonable opportunity to read, review and make informed comments.
